## New Development: it's not all bad news

NEW BUILDING DEVELOPMENT often, perhaps usually, causes problems for those who live or work close by. No exception to this has been the development to the northeast of Cross Lane (see the sketch-map, below right). Here, neighbouring residents have had to put up with noise, dust, too many large vehicles as well as the closure of Cross Lane between 22nd October and 21st December last year. And all this is before the issues which may continue after the development is finished, such as increased local traffic and in some cases, the loss of a view. However, there is a law (known as "Section 106" - see over) which exists to mitigate the impact of such development.

WITH THE CROSS Lane development, it means that Durham County Council has obtained the agreement of Persimmon Homes to provide money which is to be spent on the surrounding area. County Councillor, Heather Liddle says, "The s106 secures £200k towards the provision or enhancement of play and sporting facilities in the Division, with the following instalments:

\*£84,000 of the contribution before 29th occupation of an open market dwelling

\*£142,000 (or another £58k) before 99th occupation of an open market dwelling

\* KPPC = Kimblesworth and Plawsworth Parish Council

\*All of the money (another £58k) before 149th occupation of an open market dwelling"

WHAT EXACTLY WILL money be spent on?

This has not been decided, but according to Coun. Liddle, "the funding can only be applied for eligible projects that fit the criteria of play and sports facilities that benefit the community." Also, the funding, "is available for suitable projects anywhere in the Sacriston electoral division, therefore KPPC\* will most certainly be eligible to apply."

"There is an application and consulatation process. Once the application is completed, it is submitted to the s106 manager who will carry out the necessary checks before the application goes before the s106 panel. Approval is required from both county councillors"

#### What is Section 106?

SECTION 106 OF The Town and Country Planning Act 1990 states that, "A local planning authority may enter into an agreement," that, "may contain such consequential provisions (including financial ones) as appear to the local planning authority to be necessary or expedient for the purposes of the agreement."

# The Continuing Saga - of parking in the villages

SOME OF THE known parking hotspots around the villages are: 1) on the junction between Tanhills shops and B6312, by Acorn Close. 2) Around Tanhills shops and the turning into Tanmeads, 3) The Green and Ugly Lane at either end of the school day and 4) insufficient parking space in The Crescent. There have also been reports about large numbers of cars of people using the Community Centre at weekends and this has caused problems with residents of Glenmeads and Park View.

HOW ARE THESE issues being addressed? Following discussion with Durham County Council, white lines have been painted either side of the junction into Tanmeads opposite Tanhills shops (pictured). It is understood that a central line will be painted along the road in front of the shops to discourage double-parking, and also white lines, similar to those at the entrance to Tanmeads, at the junction of B6312.

REPORTS SUGGEST THAT the lines either side of the junction into Tanmeads have been reasonably, though not entirely, successful. We will of course have to wait and see whether the other intended changes transpire and, if so, how effective they are. It was noted that a representative of the Police suggested that, if the white (advisory) lines were not successful, they could be replaced by yellow lines for which parking on them carries a fixed penalty.

THE LONGER TERM solutions relating to provision of parking are just that (see also the "Budget" column on Page

3). It will take some time for the Council to build up the reserves to pay for extra provision. There are issues to do with ownership of proposed sites for parking and, in the case of The Crescent, it is reported that Karbon Homes's current policy is not to allow green areas to be allocated for parking. These may not be insurmountable, but the likely outcome on these points is not clear.

IT SHOULD BE pointed out to readers who drop, and pick up, children from the School that the Community Association's position is that people doing this are welcome to use its car parks (at their own risk, of course). It could be a reasonable solution to encourage this, as the Community Centre is rarely used at these times of day and the school gate next to the Crossing Patrol offers close acces to them.

FOR RESIDENTS OF Glenmeads and Park View experiencting difficulties with weekend parking at the Centre, it is understood that the group responsible has now ceased its regular meetings and will not be using the Centre again for some months. However, the fact that something similar in the future may happen does raise longer-term questions as far as the Centre's parking capacity is concerned.



While there have been some complaints about parking on them, the white lines on the turnin to Tanmeads have been thought reasonably effective so far.

## Speed

OVER RECENT YEARS there have been numerous speed control calls for measures, particularly on




the B6312 through Nettlesworth. While the Council has has a good deal of correspondence over the question of what form these should take, there has been a recurring problem. That is, according to the Police, a lack of sufficient evidence of speeding to justify such measures.

THIS LACK OF evidence is based on the results of community speed watches in Nettlesworth between 18.04.2016 and 31.08.18\*. Close observation of the data, however, shows that the earliest start time of any of the

speed watches was 9.05am, and the latest, 1.45pm. These times clearly miss the morning and evening rush hours when speeding is most likely to be an issue. A reason given by



police as to why the times speed watches are possible is limited is because there have been only two volunteers to cover twenty eight villages, but they are hoping to train more.

THIS IS AN opportunity for concerned members of the public to do something about speeding. Would you be interested in training to do community speed watches? If so, please call Donna on 07835 565393.

ON ANOTHER FRONT it is understood that, following a complaint from Nettlesworth Primary School pupils, a street sign was to be installed near Church Mews to alert drivers of the junction near the school which accesses The Green.

## COUNCIL'S BUDGET FOR 2019/20 BUDGE

THE PARISH PRECEPT is the Council's total income from local tax payers and Central Government. For 2019/20 for this financial year is £19839. The Council's outgoings include items such as financial assistance to the Community Centre and also payment to the County Council for providing extra litter and dog bins.

RESIDENTS SHOULD BE aware that the Council is ringfencing money for capital projects related to parking, speeding and play equipment. In the last financial year (2018-19), a total of £8000 was held back for this purpose. A general outline of possible projects was provided in Newsletters 13 (April, 2018) and 14 (July 2018) and may ring-fence slightly more this financial year. However, given the nature of these projects, including dealing with ownership of land, lease agreements, obtaining accurate estimates and also getting the best possible value for Council tax-payers, it will take time for these to bear fruit.

WHILE THE COUNCIL asks for residents to be patient over these matters, your ongoing feedback on such things and their related issues will be much appreciated. To give your views, please feel free to contact any councillor (contact details of members is on Page 4).
